Challenge Highlights

In this ever changing compliance environment, syndicates are subject to greater regulatory scrutiny. It demands an increase in time and effort required to meet newer reporting requirements. Compliance teams today face challenges at all levels of returns generation process.

A typical return generation process would involve data extraction from disparate source systems, integrating it and converting it into the requisite submission format and finally submitting the return. The key challenges range from dealing with data extraction and integration issues, resolving data quality issues, handling manual interventions in generating the returns, ensuring accuracy and auditability of returns, and meeting the dynamic regulatory requirements themselves. From the regulator's perspective, syndicates need to submit the returns on time, whilst maintaining high quality of data. Syndicates should ensure transparency in the return generation process, access to the returns' data elements, an ability to audit the returns as and when required.



Solution

A win-win situation would be implementing an Automated Return Generation solution which facilitates a straight through processing between source systems and the Lloyd's CMR or MDC platform.

To achieve this, automated data transformations and pre-configured business rules-based approaches should be employed as part of the solution deployment. The solution should serve automated return submission as soon as Lloyd's enables the framework (taxonomies, formats, and processes) for receiving the returns automatically.




Automated return generation

- Integrated view of returns and all dependent artefacts and support for multiple versions




Adjustments and drill-down

- Support for commentary and documentation for audit purposes.




Workflow and audit
