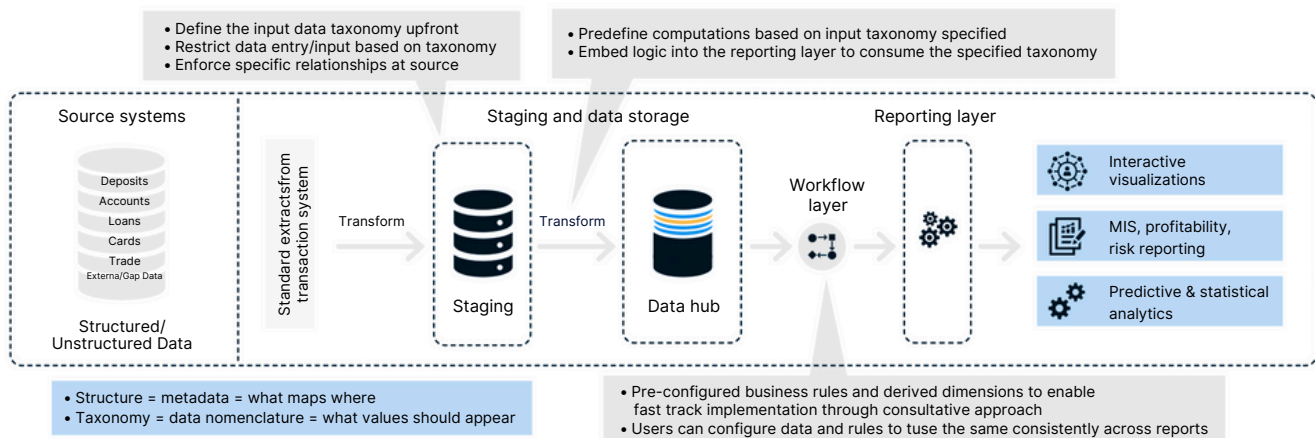


Configurable mapping interfaces
